Executive Committee Meeting Notes

Date: Friday, September 12, 2025 Time: 8:30–10:00 a.m. (via Zoom)

In attendance: Jeremy Bachelor, Christine Brooms, Melanie Eddins-Spencer, Brian Messner (ICCB), Carla Presnell, Mary Rojas-Carlson, Jean-Marie Taylor

1. Welcome and Call to Order

- Meeting called to order by Jeremy Bachelor, acting President.
- Minutes from May 23, 2025, will be re-sent by Jeremy for email approval because quorum requirements are not defined in the bylaws and members had not yet reviewed the draft.

2. President's Updates

- **Leadership Transition:** Mary Rojas-Carlson resigned; Jeremy Bachelor assumes the remainder of the presidential term.
- Several board seats are in varying cycles; elections will continue each November. We will hold a Zoom meeting for the purpose of voting, along with information about the ICCFA for attendees.

3. Vice President Position

- Discussion of options to leave the position vacant until November or appoint an interim VP.
- Members agreed that the VP should have prior ICCFA board experience.
- Action: Melanie Eddins-Spencer was unanimously appointed Interim Vice President to serve the remainder of the term.

4. Committee Structures

Regional Committees & Coordinators:

- Bylaws now state each region may have a coordinator (changed from shall).
- Proposal to create regional subcommittees where coordinators both gather local concerns and report to the ICCFA board.
- Members supported piloting this model using the successful Central Region coalition as an example.
- Motion Passed: Use grant funds to support a pilot program for re-imagined Regional Coordinators.

Teaching & Learning Initiatives Committee:

- Committee responsibilities include reviewing conference presentation proposals and grants.
- Members discussed uneven professional-development resources across the state and endorsed creating an online repository or calendar of statewide PD opportunities.

- Mary.Carlson.will.reach.out.to.COD's.Faculty.Professional.Development.team.to.explore. sharing.one.of.COD's.full_time.faculty.programs.with.faculty.across.all.Illinois.community. colleges;.
- ICCFA may co-sponsor or provide speakers for events hosted by individual colleges to broaden access and visibility.

5. Legislative and ICCB Updates

- Dual Credit updates.
- Next ICCB meeting: September 26, 2025, at Kaskaskia College.
- Goal: identify members near Kaskaskia to deliver a prepared ICCFA statement.
- Goal: plan to identify attendees for future meetings; budget for potential expenses related to meeting attendance.
